- 1. is **not** on the ballot in the election cycle for which they filed a Certification form or Filer Registration; and
- 2. is not seeking nomination or election as a write-in candidate for that election cycle.

OR

- 1. is **on** the ballot in the election cycle for which they filed a Certification form or Filer Registration; but
- 2. has ceased all campaign activity for that election cycle.

Upon filing this form, a candidate:

- 1. is required to continue filing periodic disclosure statements with the Campaign Finance Board ("CFB") pursuant to Election Law § 14-108(1); and
- 2. is still subject to all other obligations under the New York City Campaign Finance Act, including maintaining records, responding to Board requests for documentation or information, and paying penalties for violations of the Campaign Finance Act until they have disposed of all assets, satisfied all liabilities, and filed a Final Statement with the CFB; and
- 3. will no longer be eligible to receive public funds.

If you received public funds prior to terminating, you must cease spending and may be subject to immediate repayment of public funds up to the full amount received. All candidates who received public funds are subject to a post-election audit.

If you meet the qualifications above, and desire to terminate your candidacy, sign in ONE of the applicable places on the next page.
